

Cookie Policy ilmolenidno.com

This Cookie Policy describes the methods used by **MOLENDINO BED & BREAKFAST di Franchi Fabiola** (hereinafter also "Il Molendino") to manage Internet cookies on their websites. It also fulfills the function of information pursuant to art.

13 of Legislative Decree 196/2003 to the users of these sites, in accordance with the provisions of Measure General of the Authority for the Protection of Personal Data 229 of May 8, 2014.

- **Who is the owner of the data with reference to the site I'm visiting?**

The treatment, in accordance with Art. 4 of Legislative Decree no. 196/2003 is MOLENDINO BED & BREAKFAST di Franchi Fabiola, Via Nicosia 1 in Calci (PI). The data processor is the Chief Operating Officer pro tempore of MOLENDINO BED & BREAKFAST di Franchi Fabiola with reference to the different sites, can be appointed by the owner- specific data processors (eg. Il Molendino companies appointed by the management of the sites themselves). The list of these managers may be required at any time in Il Molendino, by directing a request using references later.

- **What are cookies?**

Cookies are small text files that the sites visited by the user to send his terminal (usually the browser), where they are stored before being re-transmitted to the same sites at the next visit to the same user. During the navigation of a site, you can get on to their terminals also cookie sites of different web server (cd cookie "third parties"). This is because on the website visited can be present elements as, for example, images, maps, sounds, specific links to web pages of other domains that reside on servers other than the one where you find the page you requested. There are two different types of cookies:

- Cookies technical and statistical aggregate that does not require the consent for the 'installation on the terminal user's;
- Cookies that are used for purposes not strictly technical nor statistics, however, require your consent for their use.

- **What types of cookies are used on the sites of MOLENDINO BED & BREAKFAST di Franchi Fabiola?**

Cookie technical and statistical aggregate

All of our sites, including portals that provide access to private clients, business partners and operators, using cookie technical. These cookies are needed in the following two respects:

- For conducting activities à strictly necessary for the functioning of the site: Cookies are used to save the user's session and to perform other activities à strictly necessary for the functioning of the site, for example in relation to the distribution of traffic.
- For conducting activities à rescue preferences, optimization and statistics: in this case, cookies are used to save your browsing preferences and optimize the 'browsing experience of' user. Among these cookies includes, for example, the ones to set the language and the currency or for the management of statistics by the owner of the site.

Google Analytics: Google Analytics is a web analytics service provided by Google Inc. ("Google"). Google u tilizza the personal data (usage data) with IP anonymized purpose of evaluating the use of the website, compiling reports and share them with other services developed by Google.

Google may use personal information to contextualize and personalize the ads of its own advertising network. The anonymizing IP address is performed by shortening within the borders of EU Member States or other countries participating in the agreement on the European Economic Area, the IP address of the Users. Only in exceptional cases, the IP address will be sent to Google's servers and statements within the United States. Personal information (or data)
